- iii. The vote on the stipulation does not pass, 7 yeses (BR,JR,LV,AW,RJ,SG,HH) and 8 nos and 1 abstention (HJ).
- iv. Passes unanimously with no stipulation and no amendment

Senator Roman moves to fund South Gate Giveaway in the original amount of \$1,350 and is seconded by Commissioner Soto

o. Inter Board Funding: South Gate Fall Food Giveaway
