



INTERNATIONAL STUDENT PROGRAM
TERMINATION POLICY

The International Student Program is mandated by the Student Exchange Visitor Program (SEVP) to terminate SEVIS records (i.e. I-20) assigned to students that fail to comply with the terms of their admission and enrollment responsibilities. Upon termination of the I-20, a student is considered out of status. Out of status students are no longer authorized to attend classes or participate in campus activities; but continue to be liable for unpaid fees and tuition. Out of status students are generally required to depart the U.S. but should consult with an immigration attorney to discuss their nonresident status.

REASON(S) FOR TERMINATION

Students are encouraged to review the terms of their nonimmigrant visa (F-1 Visa) prior to arriving in the United States. Information provided by the federal government is available on the U.S. Department of Homeland Security (<http://studyinthestates.dhs.gov/>). Students should also engage the International Student Program, principally the Designated School Official (DSO), if they have questions or concerns about how to maintain status. Causes of termination include:

TERMINATION PROCESS

It is the responsibility of the student to ensure that s/he maintains status. The International Student Program will, however, take steps to notify the student (i.e. email and/or phone call) of issues that impact maintaining status. The correspondence(s) will also provide the student with recommendations to resolve the issue and corresponding deadline. Failure to respond and to take appropriate steps to resolve the issue will result in termination of the SEVIS record.

RETURNING TO WEST LOS ANGELES COLLEGE

Individuals that wish to resume their program of study at West Los Angeles College must meet with the International Student Program DSO to explore options. Students may be considered for readmission to WLAC at the discretion of the Principal Designated School Official and if the following conditions are satisfied.

- Minimum cumulative 2.5000 grade point average
- Resolved all prior enrollment and tuition fees.
- Student must have completed a minimum of 9 units at WLAC in termination term.
- Submit petition and support documents (i.e. new proof of funds, Comprehensive Student Education Plan
- No history of prior SEVIS violations at West Los Angeles College or within the LACCD
